Overview

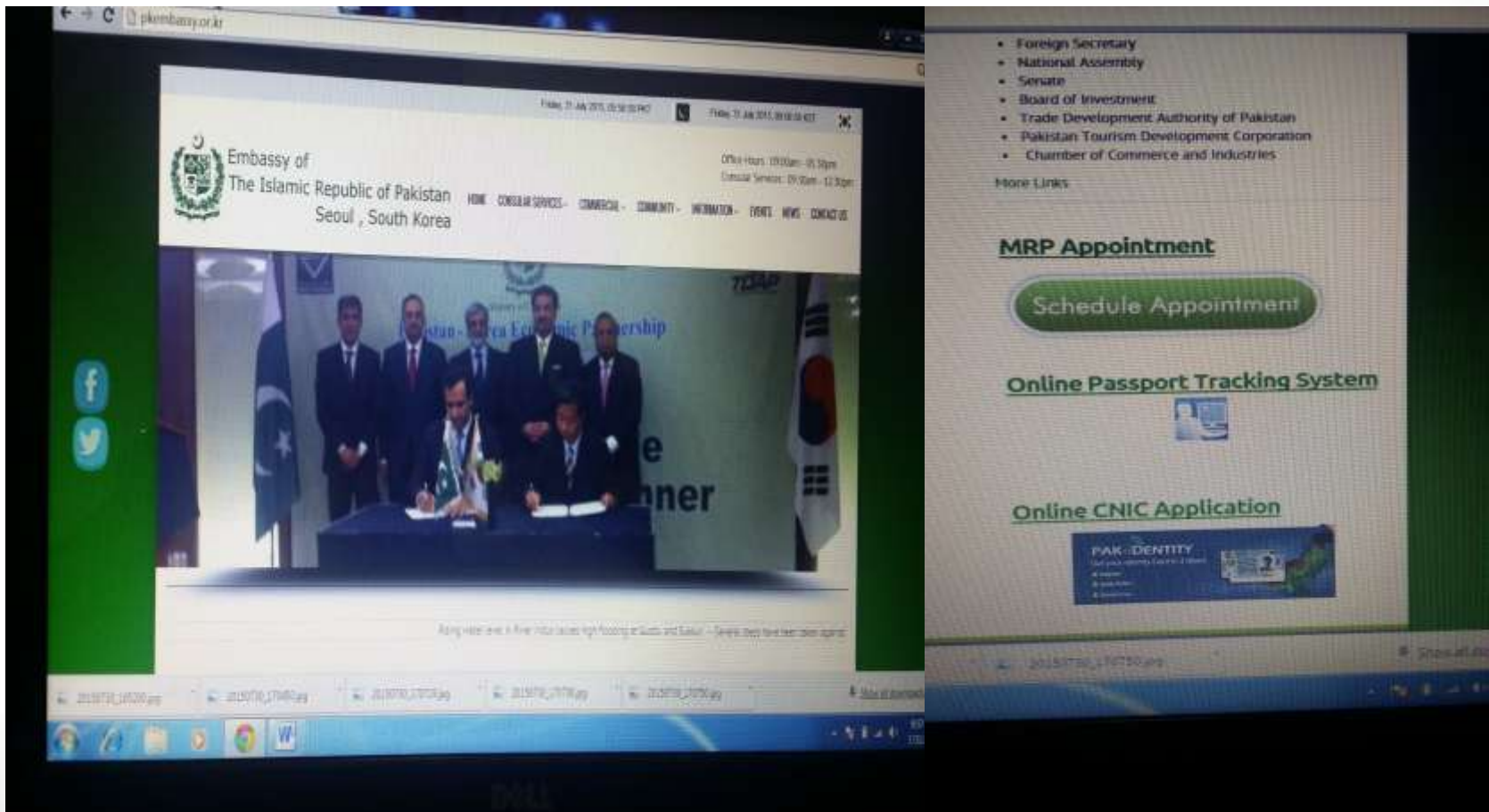
- Active in 25 Missions abroad

Requirements

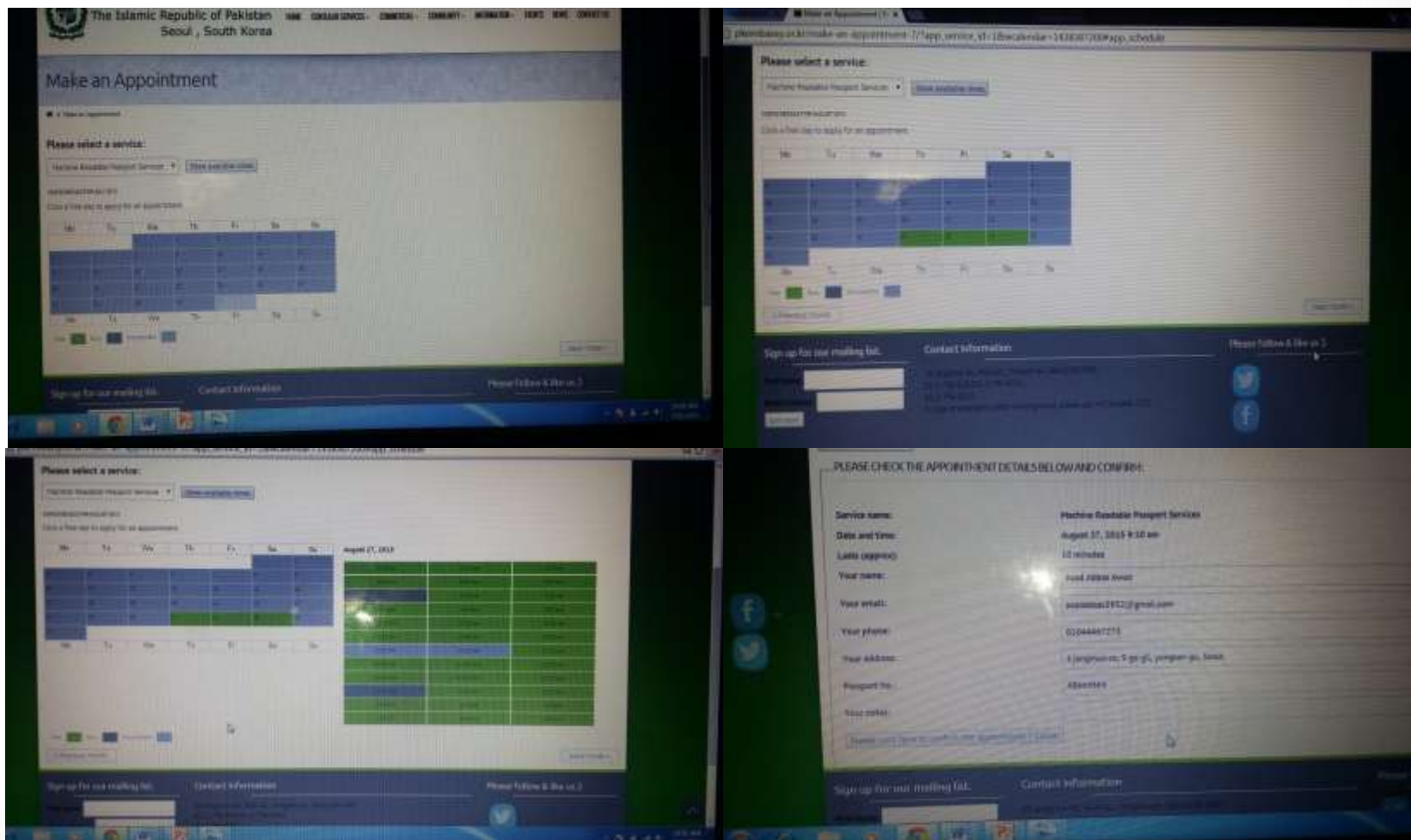
- Valid NICOP/CNIC is the primary requirement
- Valid Passport
- For under 18: CRC/RG-II NADRA form
- For married women: Father's name will be printed if name not changed to husband's
- Nadra data is the PRIMARY data

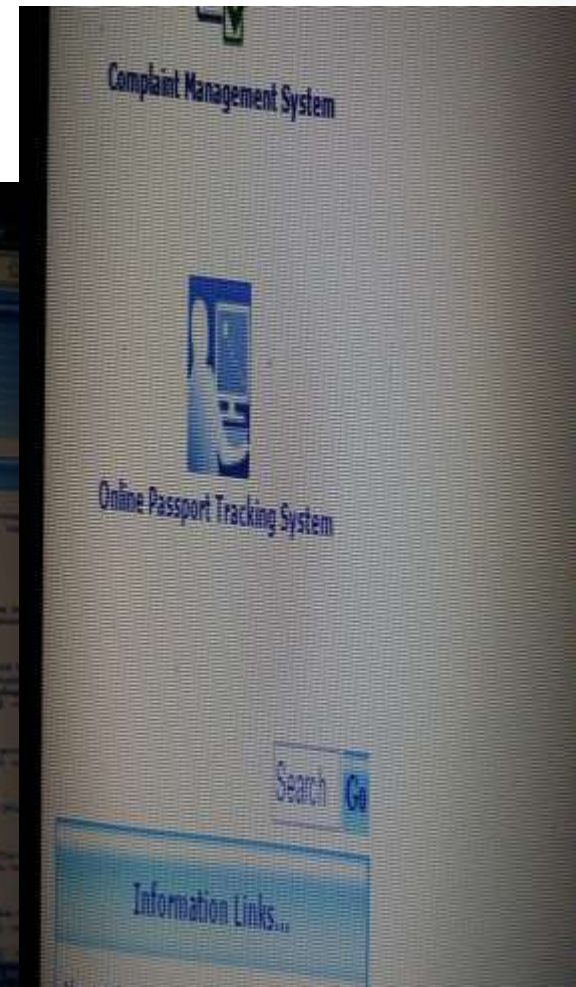
